EMERGENCY PROGRAM MANAGEMENT FOR PUBLIC SECTOR

Quickly deploy a single digital destination for constituents and communities to access emergency program information and incident updates. Use the Emergency Response Community site to feature different services and programs that are available to public agencies and hospitals, such as emergency supply requests. People can request permits for building access and apply for assistance programs like food delivery services. Using the mobile Inspection App field, responders can deliver emergency services quickly and efficiently. Businesses can use the site to request permits to reopen to the public. After the permit is approved, your inspector can use the Inspection App to verify that the site complies with local health and safety ordinances.

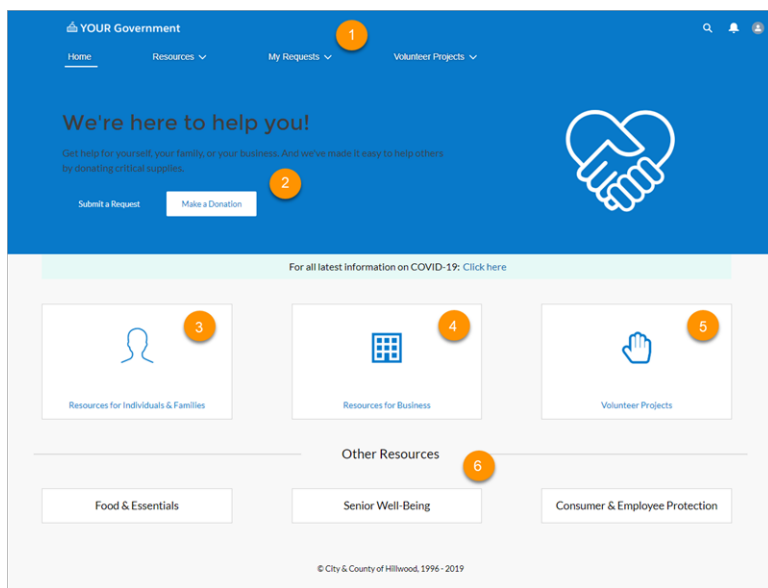

Emergency Response Community

The pre-configured Emergency Response Community template makes it easy for citizens to request emergency assistance and get information when they need it most.



The Emergency Response Community is a hub for your community during an emergency. Citizens and businesses can check the status of existing requests (1) or donate emergency supplies (2). Individuals and families can submit requests for assistance with temporary housing, emergency supply delivery, and wellness checks. Employees can request a permit to access a building or obtain certification for training they've taken (3). Businesses can request a permit to reopen to the public or request critical supplies that enable them to keep employees and customers safe (4). With Volunteer Management, you can create volunteer projects and let people sign up for shifts to help during an emergency (5). And you can add other resources to keep your community informed and protected (6).

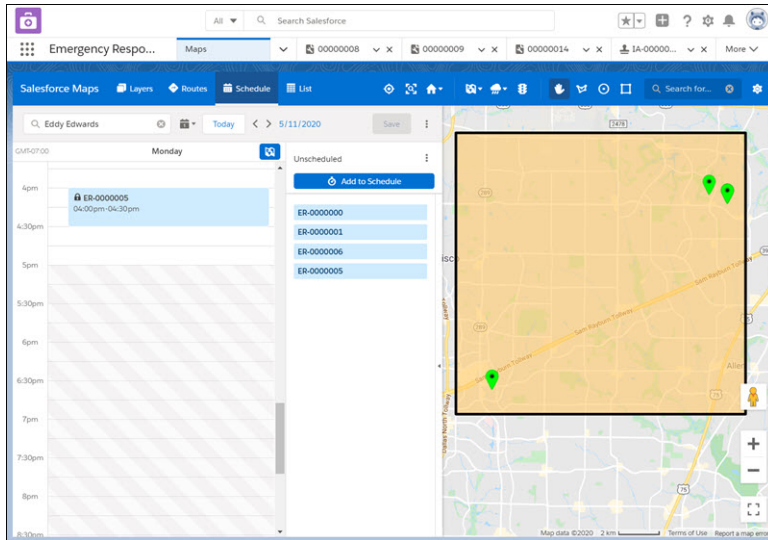
Give your staff the power of the Emergency Response Console to triage and evaluate incoming requests from citizens or businesses.

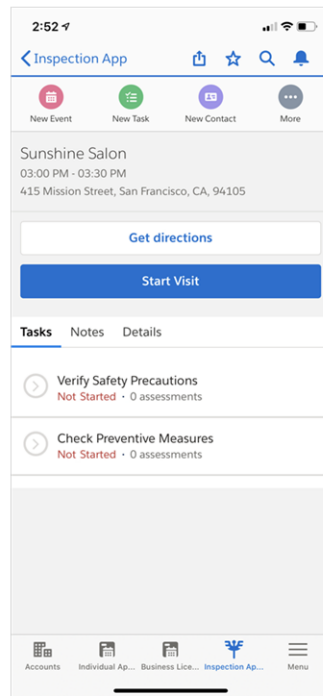
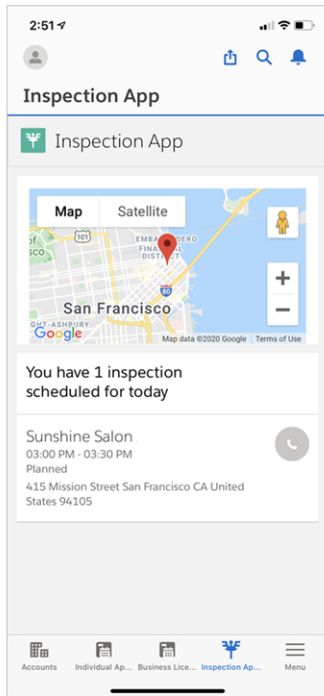
From the Emergency Response Console's home page, your agency can quickly approve requests and then have a dispatcher schedule a delivery or an inspection.

Salesforce Maps and the Mobile Inspection App

Help is on its way in no time when your dispatchers use Salesforce Maps.



Salesforce Maps injects location intelligence into field operations to make emergency supply delivery more efficient. When an emergency event is created, the Schedule an Emergency Visit process starts a flow that creates the visit record, applies the action plan template, and creates tasks.



Your field responders can complete an inspection or a delivery right on their mobile phone. Contact information, directions, and a detailed accounting of their tasks are at their fingertips. When an inspection or a delivery and the associated tasks are finished, the inspector or field responder marks the visit as complete and begins the next assignment.

Grants Management

Grants Management helps you launch a Grantee Portal where grant seekers can find funding opportunities. From the portal, organizations can apply for funding, view their application status, and submit ongoing progress reports for awarded grants.

Once you've set up Grants Management, you can create a tile in the Emergency Response site template and link to the Grantee Portal.

Install the Emergency Program Management for Public Sector packages in your org so that you can begin implementing features for your users.

 **Note:** Before installing the Emergency Program Management for Public Sector managed package, assign the EmergencyResponseMgmt and ActionPlans permission sets to the System Admin user.

1. Install the managed package for Emergency Program Management for Public Sector using this URL: <http://industries.force.com/publicsector>.
2. Make sure Experience Cloud is enabled. In Setup, search for **Settings** and select **Enable Digital Experiences**. See [Enable Digital Experiences](#).
3. Install the unmanaged package for Emergency Program Management for Public Sector using this URL: <http://industries.force.com/publicsectorerm>
4. Paste the URL for the package into your browser navigation bar and press **Enter**.
5. Enter your Salesforce password.
6. Select **Install**.

If it takes a while, you can select **Done** and move on to something else while installation finishes. Check your email for confirmation that installation was successful.

7. To verify that the package was installed, go to *Installed Packages* in Setup and look for the name of the package.



Important: Don't delete any part of the managed package after installing it. Doing so can block automatic upgrades to future releases.



Note: The custom objects, components, classes, and triggers delivered in the Emergency Program Management for Public Sector package are one API version behind the core Salesforce API. Standard objects have the same API version as core Salesforce. So, if your org's API version is 43, the Emergency Program Management custom objects are API version 42, and the standard Health Cloud objects are API version 43.

Salesforce Shield is a set of security tools you can use to comply with regulations on storing sensitive protected health information. With Platform Encryption and Event Monitoring, you can monitor usage, prevent malicious activity, and protect data at rest while allowing full functionality.

Shield Platform Encryption

Platform Encryption allows you to natively encrypt your most sensitive data at rest, allowing you to address HIPAA requirements for storing sensitive protected health information. Encryption helps you protect PII, PHI, sensitive, confidential, or proprietary data. It enables you to meet both external and internal data compliance policies while keeping critical app functionality—like search, workflow, and validation rules. You keep full control over encryption keys and can set encrypted data permissions to protect sensitive data from unauthorized users. Event Monitoring

Event Monitoring gives you access to detailed performance, security, and usage data on all your Salesforce apps. Every interaction is tracked and accessible via API, so you can view it in the data visualization app of your choice. See who is accessing critical business data when, and from where they're getting access. Understand user adoption across your apps. Troubleshoot and optimize performance to improve end-user experience. Event Monitoring data can be easily imported into any data visualization or application monitoring tool like Analytics, Splunk, or New Relic. Set Up an Organization-Wide Email Address

Define a list of organization-wide addresses for different user profiles. When they send email from Salesforce, these users can select their own email address or the organization-wide email address for the email's From field. Replies are delivered to the selected address.

1. From Setup, enter *Organization-Wide Addresses* in the Quick Find box, then select **Organization-Wide Addresses**.
2. To manage organization-wide addresses, use the available options.

To use an organization-wide address, send an email from Salesforce and choose your organization-wide address from the dropdown list.

Create User Profiles

Create user profiles to quickly add new users to the same permissions and field-level security settings.

Start by cloning the Standard User profile.

1. From Setup, enter *Profiles* in Quick Find, then select **Profiles**.
2. Clone the Standard User profile.
3. Give the profile a name to identify the type of user, such as *Reviewer* or *Service Dispatcher*.
4. Save your changes.
5. Click Edit and give permission to Emergency Program Management objects.
6. Save your changes.

You can now create users based on this profile.

3. In Custom App Settings, select **Visible** for the Emergency Response Console app.
4. In Custom Object Permissions, for Emergency Requests, select **Read, Create,** and **Edit** for the Standard ERM User and select **View All** and **Modify All** for the admin user.
5. In Custom Field-Level Security, select Emergency Request. Enable both Read Access and Edit Access for all fields for both the Standard ERM User and for the admin user.
6. Click **Save**.

Configure Field-Level Security for Users

Field-level security specifies the access level for each field in an object.

Sometimes, you want users to have access to an object, but limit their access to individual fields in that object. Field-level security—or field permissions—control whether a user can see, edit, and delete the value for a particular field on an object. They let you protect sensitive fields without having to hide the whole object from users. Field permissions are also controlled in permission sets and profiles. Set access on fields based on what type of access your users require.

 **Note:** To enable your company's employees to request location access permits or training certificates, add them as internal users with Platform Starter or greater licenses.

1. From Setup, enter *users* in the *Quick Find* box, then select **Users**.
2. Click **New User** to add a single user or click **Multiple Users** to add up to 10 users at a time.
3. If multiple user license types are available in your organization, select the user license to associate with the users you plan to create. The user license determines the available profiles.
4. Specify the information for each user, including *Role* and *Profile*.


If you use Salesforce Knowledge articles to manage protocols, enable `Knowledge User` for every user needing access to articles.

- To email a login name and temporary password to each new user, select **Generate new password and notify user immediately**.
- To specify more details for the users that you create, edit individual users as needed.

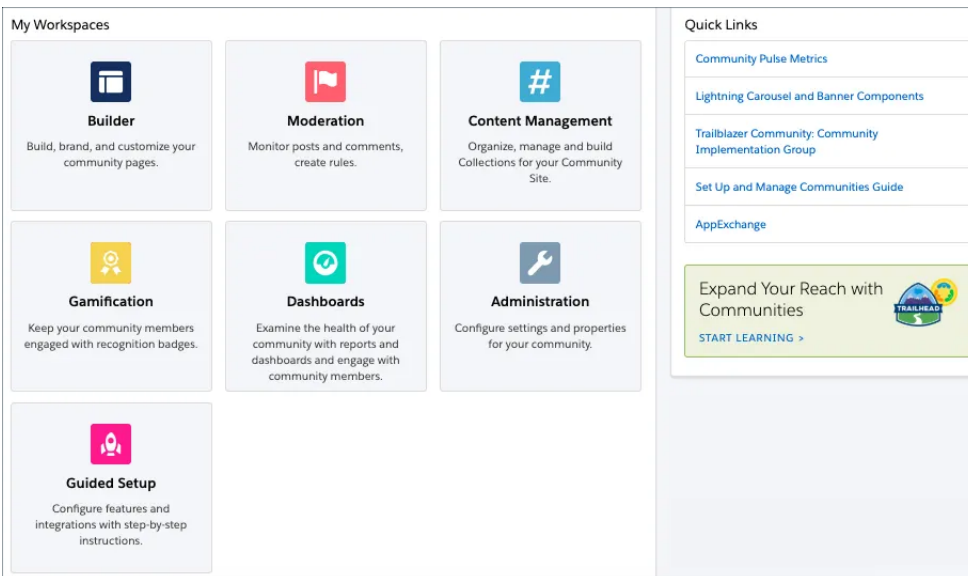

The Site Creation wizard opens with several Emergency Program Management Site templates for you to choose from.
- Select the Emergency Response Site template.
The Emergency Response Site makes it easy for citizens to request emergency assistance and get information when they need it most. Businesses also can request critical supplies that enable them to keep their employees and customers safe and healthy.
- Click **Get Started**.
- Enter a site name.
- For URL, enter the name of your site.
This name is appended to the domain that you created when you enabled Digital Experiences for this org. For example, if your site’s domain name is *CountyPublicHealthDept.my.site.com* and you’re creating an Emergency Response site, you can enter *EmergencyResponseSite* to create the unique URL *CountyPublicHealthDept.my.site.com/EmergencyResponseSite*.

 **Note:** You can create one site that doesn’t have a custom URL.

- Click **Create**.
Experience Workspaces opens, where you can build and administer your site. Your new site is in Preview status, meaning it’s not available to your users yet.

Salesforce creates a separate person account for each self-registering user. You can specify a default profile while setting up the self-registration. 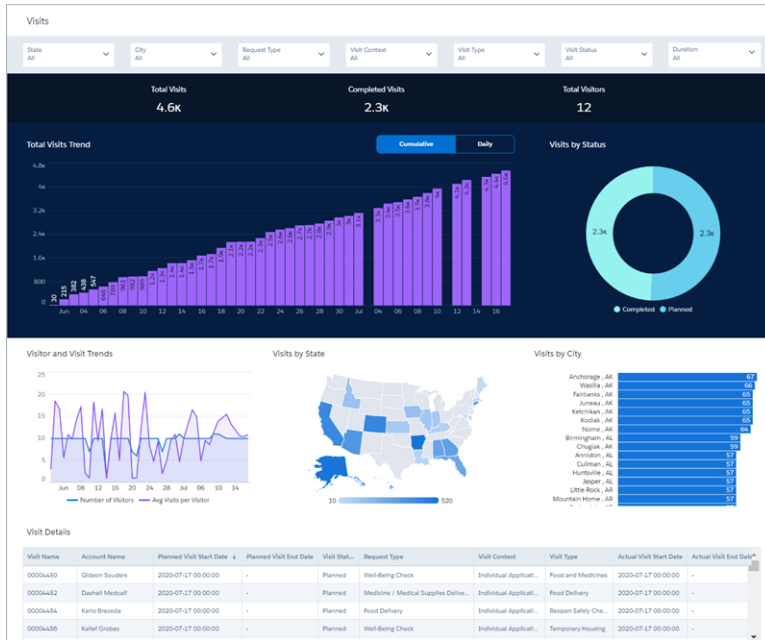
